**ALLOTMENT OF POST FOR PROVISIONALLY EMPANELLED
CANDIDATES AGAINST CEN 02/2018**

Against 2367 notified vacancies of Eastern Railway in Centralized Employment Notice No. CEN02/2018, from the document verification cleared and medically fit candidates, a provisional panel of 2079 candidates was published vide web notices of RRC/ER dated 16/07/2019, 13/09/2019 and 03/12/2019.

Further to that, a panel of 27 candidates was published vide web notice of RRC/ER dated 15/07/2021 which included extra candidates called in DV who had cleared DV & Medical. Later a panel of 12 candidates was published against the unfilled vacancies of CEN 02/2018 which included 07 candidates found fit after re-medical and other dispute cleared candidates vide web notice of RRC/ER dated 27/12/2021.

Also, Md. Pintu Ali Roll No-222137081161873, who was removed from panel on 13.09.2019 due to dispute regarding his medical status, after getting clarification from medical department, is being re-included in the panel.

Details regarding allotted post and place of posting, for 40 provisionally empanelled candidates, against CEN-02/2018 are given below. Allotment of posts, divisions/units of empanelled candidates is based on left over vacancies, medical fitness and administrative requirements. The candidates who were called as per merit for giving their option for posting at Metro Railway and who submitted their NOC, 26 of them have been given posting at Metro Railway as per administrative demand.
