The candidates will be required to produce the original certificates in support of their claims pertaining to age, educational qualifications including cultural qualification (Degree/Diploma/Certificate in respective discipline only from Govt. recognized University/Institute), community, and other claims by the candidates. All original certificate testimonials (Academic & Cultural) alongwith attested copies of documents (by Gazetted Officer) & Two Copies of Passport size Photograph (same as upload in online application form). In case of failure, candidate will not be allowed to appear in the Practical Demonstration Test.
5. Candidate should also bring their own Instrument for performance test. Only Mike, Light and Stage will be made available.
