E. Candidates are instructed to go through the DV instructions for CEN02/2018 which is available on website of RRC ER & follow them scrupulously. They are instructed to bring the following documents –

- 1) Candidates should bring all certificates and papers in original and self attested copies as per CEN02/2018 Notification.
- 2) Candidates should bring their portion of CBT & PET call letters.
- 3) Candidates should bring educational qualification certificates in original along with self attested Xerox copies.
- 4) Candidates should bring Caste certificate in the format annexed with CEN-02/2018 and issued by proper authority. OBC certificate should not be older than one year.
- 5) Candidates should bring Age proof certificate. Only Date of Birth mentioned in class 10th certificate would be accepted.
- 6) Candidates should bring Aadhaar card. If Aadhaar is not available, then any ID proof issued by Govt. authority such as Voter ID, PAN card etc.
- 7) Candidates should bring 08 copies of passport size photo graph which was uploaded at the time of online application.
- 8) In case of any discrepancy in documents regarding spelling difference etc. the candidate should submit affidavit from First Class Judicial Magistrate.
- 9) After Biometric Match and DV clearance, the candidate will be sent for Medical Examination at Railway Hospital. Hence, candidate shall have to make self arrangement for stay for 2-3 days.
- 10) A link will be provided on the notice board of official website of RRC/ER for down loading e-call letter. No correspondence will be made through post. Candidate should keep registered mobile no. & Email ID working and check RRC ER website for regular updates.
