NOTICE FOR BIOMETRIC / PHOTO / SIGNATURE MISMATCHED CANDIDATES AGAINST CEN 02/2018

The Document Verification (DV) of candidates against CEN - 02/2018 was held from 30/04/2019 to 22/05/2019. During the DV process total 117cases of Biometric / Photo / Signature mismatch were reported.

A further re-check of such cases was done on 21/05/2019 and 22/05/2019 and the cases which were not cleared on these days, for them and indicative notice was uploaded on the official web site of RRC/ER on 25/05/2019 informing that such candidates would be called for re-check after giving them a notice of 10 days.

Accordingly, on 14/06/2019, it was notified through website & e-mail to each biometric / photo / signature mismatched candidates on their registered e-mail ID, to report to RRC/ER on 27/06/2019 for verification of their credentials. A paper notification in three leading News Papers of Bengali, English & Hindi was also published on 19/06/2019. Those candidates whose e-mail was not delivered, they were also sent notice through Speed Post. Out of 117 mismatched cases, 71 such candidates attended RRC/ER on 27/06/2019. Their Biometric check for CBT and PET was done through the agencies involved in the conduct of CBT & PET. Besides that, opinion of Railway Finger Print Expert (FPE) was taken. Those cases which were not cleared on 27/06/2019, such candidates submitted samples of their handwriting and LTI for GEQD verification.

However, 46 candidates did not report on 27/06/019. For them a final call was given through notice on website and e-mail to their registered e-mail ID on 05/07/2019 to submit samples of handwriting and LTI at RRC/ER on 11/07/2019. Out of 46 such candidates 06 candidates reported and submitted samples of their handwriting and LTI.

Absentees of DV against CEN 02/2018 were given opportunity to attend DV on 26/06/2019. Out of 105 absentees only 24 attended on 26/06/2019. Out of 24 candidates, 16 cases of Biometric / Photo / Signature mismatch were detected. The candidates whose Biometric / Photo / Signature found mismatched, submitted their handwriting and LTI for GEQD verification.

Total 83 Biometric / Photo / Signature mismatched cases of candidates pertaining to CEN 02/2018 were sent for GEQD / Forensic Report along with the samples Handwriting & Finger Print. Details are notified below :
