

**RESULT OF CBT**  
**GDCE -01/2019 for the post of**  
**Commercial Clerk cum Ticket Clerk and Junior Clerk cum Typist**

**N O T I C E**

- I.** The CBT for the GDCE -01/2019 (Junior Clerk cum Typist and Commercial Clerk cum Ticket Clerk) was conducted on 28.10.2021. An opportunity for raising objections regarding Answer Key was given to CBT appeared candidates from 11.11.2021 to 22.11.2021 vide notice no. RRC/ER /GDCE/01/2019(60) dated 11.11.2021 through the link provided on RRC-ER website.
- II.** After closing of the objections related issues by the concerned authority, the result of CBT is finalized. One question (Q.ID No.504078441) did not have any of the answer options as correct option. Hence, the question (Q.ID No.504078441) has been dropped for all candidates and marks have been given on the basis of evaluation of 99 questions for each candidate. Accordingly the pass marks as given in the notification, for general and reserved community candidates has changed.
- III.** The result of CBT is uploaded herewith on notice board of RRC-ER website. The list is in alphabetical order and the mark obtained by each candidate is mentioned along with the name, roll no. and community of the candidates. Also, the result status of the candidates has been indicated. The result status of the candidates is in reference to the community mentioned by the candidates in their online applications and as per position sent by the units, duly following extant rules regarding relaxation/benefits for reserved communities.
- IV.** **CBT qualified candidates must note that passing in CBT does not confer any right for coming in the select list. Their candidature for GDCE is**

**purely provisional, subject to the condition that they fulfill the entire eligibility criterion as mentioned in the notification.**

- V. For next stages of GDCE, the candidates are advised to follow Notice Board of RRC-ER website for further instructions, dates and processes.**
- VI. The schedule for DV & TST (wherever applicable) and E-call letters for Document Verification will be uploaded on the website and no communication will be made through post. CBT qualified candidates are advised to keep alive their registered e-mail and phone number and check the official website of RRC-ER notice board regularly for updates.**
- VII.** First, the CBT qualified candidates, who have opted for the post of Commercial Clerk cum Trains Clerk, will be called for document verification (DV) as per community wise merit in CBT, in the ratio of 1:1 of notified vacancies. Further, extra 50% candidates in reference to notified vacancies, as per community wise merit in CBT, will be called for document verification (DV). However, provisional select list will be prepared only in the ratio of 1:1 of notified vacancies, after clearing document verification (DV) and following other relevant guidelines. Such enlisted candidate will have to be declared fit in respective medical category before final empanelled.
- VIII.** Biometric verification with CBT records will be conducted on the day of document verification (DV). The candidates whose biometric verification report will be positive, they will have to submit the relevant original documents before the committee nominated for document verification. If a candidate fails to do so then it will immediately lead to cancellation of candidature. The candidates, whose biometric verification report will be negative, for them forensic check will be conducted through government authorized experts. Their candidature will be decided on the basis of forensic report and decision taken by Chairperson RRC on the basis of facts and rules.

- IX. Candidates who clear the DV for the post of Commercial Clerk cum Trains Clerk and are provisionally placed in the select list for the post, they will not be considered for the post of Junior Clerk cum Typist. However, their appointment will be subject to clearing the medical fitness requirements for the respective post and other verifications conducted by units.**
- X.** Candidates who have either opted for the post of Junior Clerk cum Typist or opted for both the posts of Junior Clerk cum Typist and Commercial Clerk cum Trains Clerk while filling up online application and do not find their place in the provisional placed in the select list of Commercial Clerk cum Trains Clerk before medical examination, they will be called for Typing Skill Test (TST) as per community wise merit in CBT, in the ratio of 1:8 of notified vacancies as per extant rules.
- XI.** The document verification of candidates for the posts of Junior Clerk cum Typist and Commercial Clerk cum Trains Clerk will be conducted only for those candidates, who will pass the Typing Skill Test (TST) and will be coming in the zone of consideration as per community wise CBT merit in the ratio of 1:1 of notified vacancies. 50% extra candidates will be called to cater to absentees and biometric mismatch candidates. Provisional select list will be done in the ratio of 1:1 of notified vacancies, subject to fulfillment of all criterion and guidelines. Rest of the processes will be same as mentioned at Para IV & V above.
