URGENT NOTICE

1. On the basis of results of the written examination for recruitment against Scouts & Guides Quota for Erstwhile Group 'D' (Level-1) and Group 'C' (Level-2) for the year 2019-20 held by RRC-ER on 29/02/2020 at CPO's Office, First Floor, Eastern Railway Headquarters, Fairlie Place, Kolkata, the candidates with the Application numbers, as given below, have qualified for the Stage-II of the recruitment process i.e. Marks on Certificates and Verification of Documents.

2. Candidature of these candidates is purely provisional subject to their being found eligible in all respects. The candidates will be required to **produce the original certificates** in support of their claims pertaining to age, educational qualifications including Scouts & Guides qualification, community and other claims by the candidates. **One set of all certificates self-attested, 4 copies of pass-port size photos, which was earlier provided and any photo ID proof**, issued by Govt. of India or State Govt. i.e. Voter Card, Aadhar Card, Driving Licence, Passport etc. are required to bring on the day of Stage-II recruitment process.

3. If it is found at any stage of the recruitment that the candidate does not fulfil all/any of the conditions of eligibility, his/her candidature will be cancelled without any notice and no appeal against such cancellation will be entertained.

4. **The Stage II of the recruitment process for Erstwhile Group 'D' category is expected to be held around last week of March,2020.** The time and venue for the same will be intimated to the eligible candidates in due course.

5. **The Stage II of the recruitment process for Group 'C' category is scheduled to be held on 24/03/2020 at 12.00 P.M. at the chamber of Chief Personnel Officer/IR, Eastern Railway, 1st Floor, 17, N.S. Road, Fairlie Place, Kolkata – 700 001.**

6. **The candidates must note that there will be no separate call letter for Stage-II recruitment process and this notice may be treated as the call for the said examination. The candidate must bring the retained portion of the e-call letter of the written examination on the specified date at the specified venue and time.**

7. The candidate with the following Application numbers are advised to visit the website of RRC-ER i.e. www.rrcer.com at least once every day for latest updates regarding the recruitment process and all other details. Further, candidates are also **advised to refer to the detailed notification** for the recruitment against Scouts & Guides Quota dated 25/10/2019 published on RRC-ER website for required documents and other instructions.

8. No request, whatsoever, shall be entertained in any circumstances for change of date for the stage II of the recruitment process for both Erstwhile Group 'D' and Group 'C' category.

9. Marks obtained by all candidates shall be uploaded on the website of RRC-ER within one month of the declaration of the final results i.e. after all the stages are completed and results are declared.

Administrative decisions would be binding on candidates.**
