**PROVISIONAL EMPANELMENT OF CANDIDATES AGAINST
UNFILLED VACANCIES OF CEN 02/2018**

A. Against 2367 notified vacancies of Eastern Railway in Centralized Employment Notice No.02/2018, initially 2384 candidates were called for Document Verification, as per guidelines issued by Railway Board for CEN 02/2018. From the document verification cleared and medically fit candidates, a provisional panel of 2079 candidates was published vide RRC/ER's notices dated 16/07/2019, 13/09/2019 and 03/12/2019. Further to that, a panel of 27 candidates has been published vide RRC/ER's notices dated 15/07/2021 against CEN 02/2018.
