Instructions to eligible candidates for Stage - II of recruitment process for Scouts & Guides quota recruitment (Erstwhile Gr.'D' posts) for the year 2019-2020.

1. Candidates must bring originals of all certificates in support of their claims pertaining to age, educational qualifications including Scouts & Guides qualification, mark sheets, community and other claims by the candidates.
2. Candidate must bring one set of self attested photocopies of all certificates. They must also bring at least one photo ID proof viz. Voter ID, AADHAR card, PAN Card, Passport , Driving License etc. Four passport size photographs identical to the one submitted with application form must be brought as well.
3. All certificates must be in prescribed format as per the notification.
4. The candidates must note that there will be no separate call letter for Stage-II of the recruitment process and this notice may be treated as the call for the said examination. **The candidate must bring the retained portion of the e-call letter of the written examination on the specified date at the specified venue and time.**
5. No request, whatsoever, shall be entertained in any circumstances for change of date for the Stage-II of the recruitment process for erstwhile Group 'D' category.
6. RRC/ER reserves the rights to change the time, date, & venue of the aforesaid Stage –II of recruitment process.
